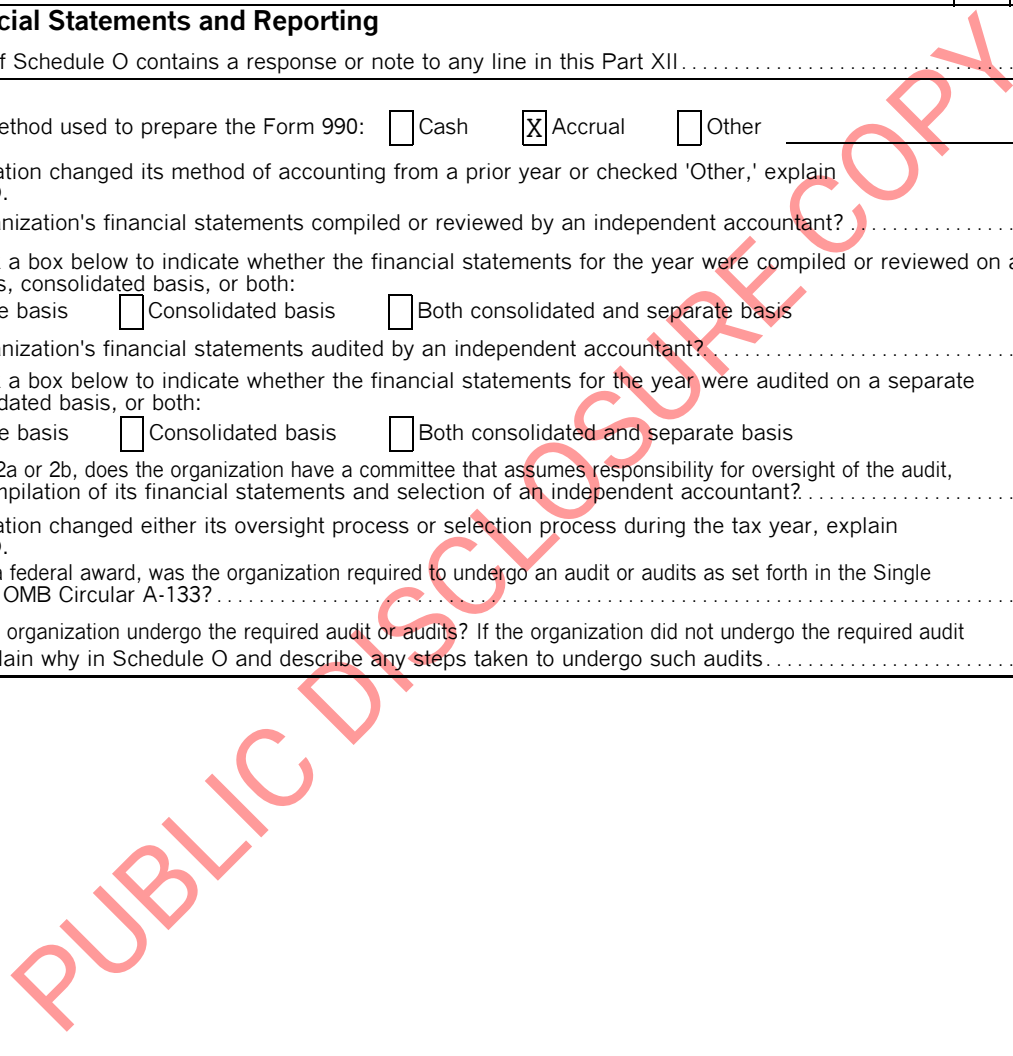

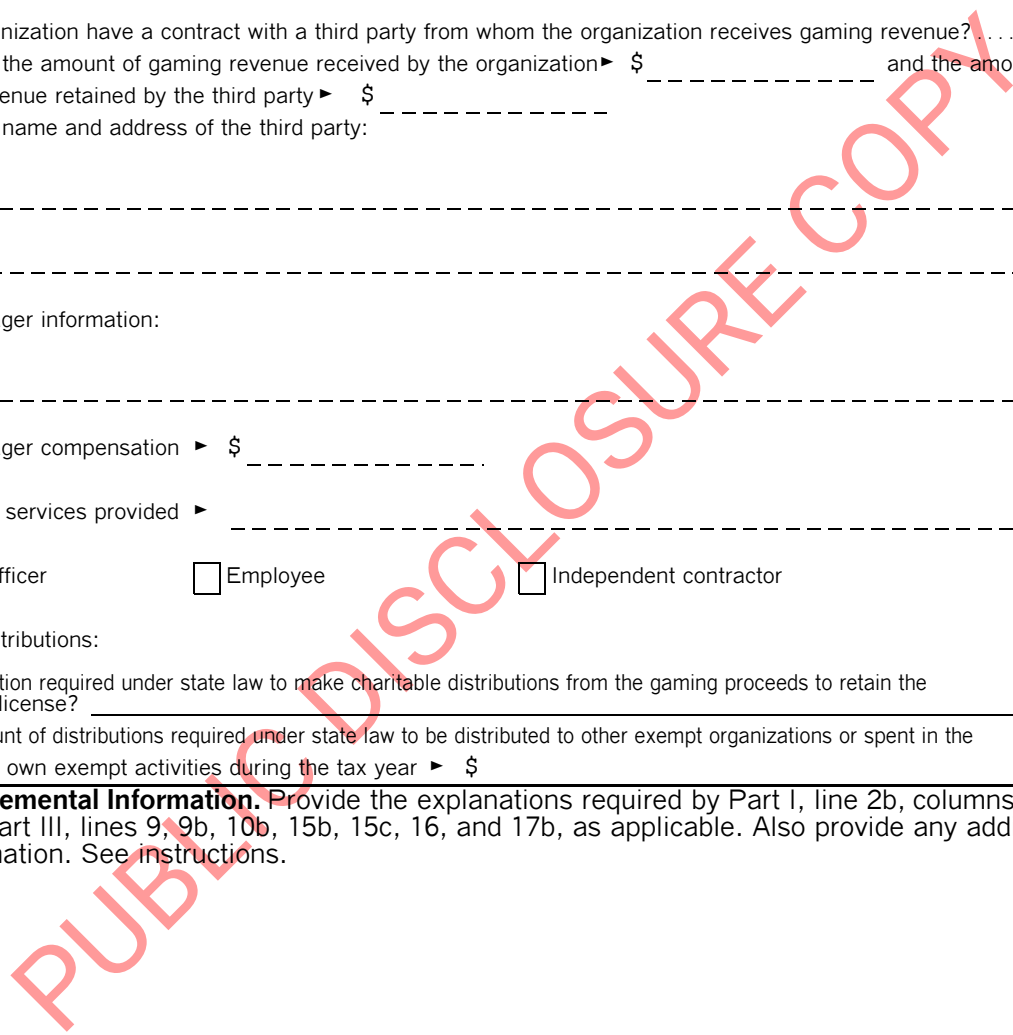

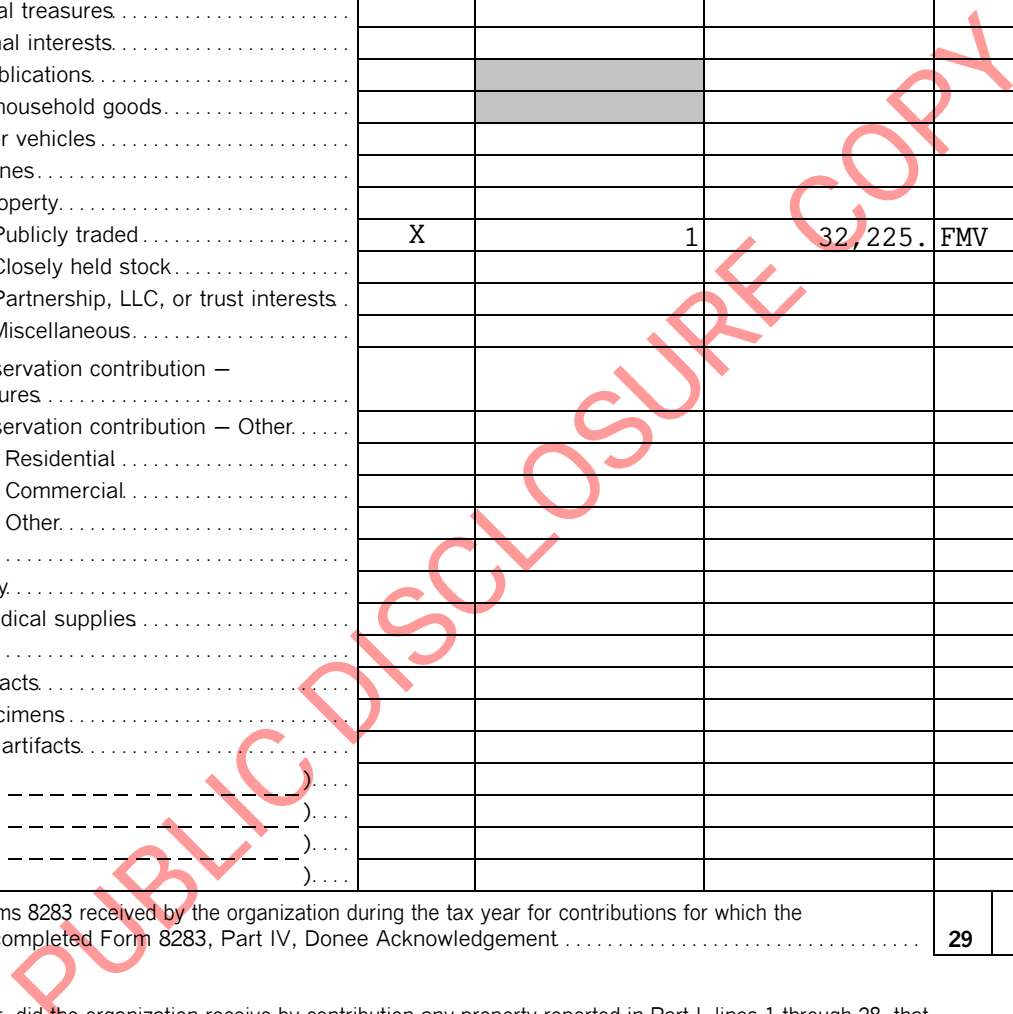

IN 2012, THE NEWEST BUILDING WAS ADDED TO HOUSE STATE-OF-THE ART SURGICAL SUITES AND SPECIALIST CLINIC SPACE. THE HOSPITAL NOW PROVIDES SERVICES IN 26 SPECIALTIES, INCLUDING ALLERGY, CARDIOLOGY, DENTISTRY/ORTHODONTICS, EAR/NOSE/THROAT, ENDOCRINOLOGY, DERMATOLOGY, GASTROENTEROLOGY, INFECTIOUS DISEASES, NEPHROLOGY, NEUROLOGY, NUTRITION, OPHTHALMOLOGY, PHYSIOTHERAPY, PULMONOLOGY, PSYCHOLOGY AND SURGERY.

AS OF 2017, HOSPITAL INFANTIL HAS PROVIDED WELL OVER 530,000 PEDIATRIC CONSULTATIONS, MORE THAN 15,000 SURGERIES, AND HUNDREDS OF THOUSANDS OF HOURS OF SERVICE BY VOLUNTEERS FROM THE US, CANADA AND MEXICO.
